I respectfully submit the enclosed materials for review by Homeland Security Investigations concerning potential unauthorized employment of a foreign national following expiration of J-1 work authorization in December 2022.


The enclosed complaint sets forth publicly available evidence indicating that Amanda Raissa Barbosa, a Brazilian national, may have continued full-time domestic employment in a private household of Eric Swalwell from January 2023 through early 2025 following expiration of her J-1 Exchange Visitor authorization. The materials further identify public records suggesting employer knowledge of the visa expiration and continued apparent employment thereafter.

This submission is based solely on publicly available records, including visa timelines, federal campaign disbursement reports, public employment filings, social media documentation, and related materials. A structured narrative and labeled exhibits are enclosed for ease of review.

I respectfully request that Homeland Security Investigations evaluate whether proper employment authorization existed during the relevant period and determine whether any violations of federal immigration, labor, or tax laws occurred.

I declare that the enclosed materials are true and accurate to the best of my knowledge and belief.

- No publicly available documentation indicates further employment authorization following expiration of the J-1 extension.

#### **4. Summary of Allegations**

I respectfully submit this complaint alleging that Eric Michael Swalwell and Brittany Watts Swalwell may have continued employment of a foreign national without work authorization for approximately two years, from January 2023 through February 2025, following the expiration of her J-1 au pair visa status.

The foreign national, Amanda Raissa Barbosa, worked lawfully as a full-time live-in au pair for the Swalwell household during 2022 under a J-1 visa (Au Pair ) to care for their three small children (and dog). During 2022, Barbosa was paid weekly by the Swalwell campaign under the expense category “Childcare for Campaign Event” according to his FEC filings, for a total of \$46,930 (Exhibit L).

Public records indicate Barbosa’s J-1 work authorization ended December 28, 2022. Despite this, publicly available records suggest that Ms. Barbosa continued residing in the Swalwell household and performing full-time childcare and domestic labor (Exhibits G, H), without valid work authorization, until early 2025.

#### **5. Evidence of Knowledge and Intent**

##### **a. Attempted PERM Labor Certification (March 2022)**

In March 2022, Brittany Watts Swalwell filed an Application for Permanent Employment Certification (ETA-9089) on behalf of Ms. Barbosa for a live-in household nanny position (Exhibit A). This application was later rejected (Exhibit C) as J-1 Visa au pair status does not permit such conversion. This PERM filing demonstrates advance knowledge that Ms. Barbosa’s J-1 visa authorization would expire in December 2022 and that continued employment required new legal authorization.

As required to obtain the Permanent Employment Certification, Brittany Watts Swalwell (“BWS”) advertised the position’s responsibilities twice in *The Washington Post* on October 23 and October 30, 2022 (Exhibit B). The ad detailed Barbosa’s extensive work duties:

*BWS Family, DC family of 5 w/ 2 working parents seeks live-in nanny to assist w/ taking care of 3 kids & help satisfy kids’ physical, emotional, intellectual, & social needs. Duties: -- Live-in residence (free). Child-care for 5 y/o, 4 y/o & 12 mo old, flexible to work evenings, overnight, weekends, & holidays, assist w/ care of dog, organize kids’ play activities, drive kids to appts & activities (prefer 6 mo DC driving experience), do light household cleaning & laundry, prep kids’ meals, 2 years of child-care experience.*

*Schedule: Mon to Fri, 7A to 4P (end time could change depending on parents' schedule/will be discussed every wk. Wknd work time discussed every other wknd.). Salary: \$37,378 annually + potential overtime. Resumes to: DChouseholdnannyjob@gmail.com*

**b. Expiration of J-1 Visa Status (December 28, 2022)**

Public records indicate Ms. Barbosa's J-1 visa work authorization expired on December 28, 2022.

**c. Continued Residence and Apparent Employment (January 2023–February 2025)**

- Ms. Barbosa has resided full time at the Swalwell residence at 209 S Street NE from December 2021 to present
- Public social media photos from 2023-2024 show Barbosa caring for the Swalwell children, traveling with the family, attending events, and engaging in childcare-related activities similar to those performed during her authorized J-1 period (Exhibits F, G, H).
- No substitute full-time childcare provider appears in Swalwell campaign filings during 2023–2024 (Exhibits M, N). This is despite the child care and duties the two working parents required according to *The Washington Post* ads (Exhibit B).
- Barbosa's LinkedIn page states "Childcare Provider" – Full Time" (Exhibit D).

- Barbosa enrolled at Northern Virginia Community College in August of 2023, taking two academic years to complete a one-year certificate (likely with an F-1 Visa), and may warrant review as to whether she was working full time for the Swalwells. An F-1 student visa does not permit full-time domestic employment in a private household. According to F-1 rules, it allows for on-campus work only and 20 hrs/week during semester.

**d. Campaign Payment Patterns**

- In 2022, Ms. Barbosa was paid weekly through Eric Swalwell's campaign (Exhibit L).

- In 2023 and 2024, no direct payments to Ms. Barbosa appear and no substitute full time child care worker was paid by the Swalwell campaign (Exhibits M, N).
- On November 3, 2023, Eric Swalwell charged his campaign \$9,713.42 for “Payroll Tax for Campaign Childcare Reimbursement” (Exhibit M). The reimbursement raises questions as to the nature of the underlying payments.
- In February 2025, Ms. Barbosa reappears in campaign disbursements after two years and receives regular weekly payments totaling \$40,439.83, suggesting a new lawful work authorization (Exhibit O). She may have been paid an additional \$16,131.37 according to additional reimbursements to Eric Swalwell.

## 7. Detailed Timeline of Events

### December █, 2020

Brazilian citizen Amanda Raissa Barbosa, then age 28, obtains a 12 month J-1 Au Pair visa through sponsor Au Pair in America. Her goodbye party in Brazil is posted on her Facebook (Exhibit E). The J-1 Au Pair program is administered by the U.S. Department of State under the Exchange Visitor Program, specifically 22 C.F.R. § 62.31. The program authorizes an initial period of 12 months of au pair participation, with one possible extension of up to 12 months. After completion of the program, employment authorization terminates immediately.

### January 2021 – August 2021

Barbosa lives in Gig Harbor, Washington, serving as a live-in au pair for James Trahon and Barbosa Wills. Her posts show Barbosa living and traveling with the family in 2021 (Exhibit E).

### September 14, 2021

Barbosa posts photos indicating she is visiting Cabo Frio, Brazil, allowed under the J-1 Visa.

### **October 6, 2021 – November 2021**

Barbosa's Facebook posts place her in Washington, D.C. (Exhibit E), where she begins working for Eric Michael Swalwell and Brittany Watts Swalwell, who have three small children (then ages 4, 3, and a newborn). FEC filings show the Swalwell campaign paid Barbosa for Child Care the weeks of: October 6, 2021 (\$678.2) and November 1, 2021 (\$1,108.80) (Exhibit K).

### **December 2021**

Barbosa appears to be the full-time live-in au pair for the Swalwell household, residing in their home at 209 [REDACTED] Street NE, Washington, D.C. Barbosa likely obtained a 12 month extension of her J-1 visa through 2022. During December 2021, the Swalwell campaign paid Barbosa weekly for four full weeks under the category "Childcare for Campaign Event" (Exhibit K).

### **January 1, 2022 – December 30, 2022**

Throughout 2022, Swalwell campaign filings show weekly payments totaling \$46,929.70 to Barbosa for "Childcare for Campaign Event." Corresponding weekly childcare reimbursements were taken by Eric Swalwell from the campaign in matching amounts (Exhibit L).

### **March 22, 2022**

Brittany Watts Swalwell tried to legalize Barbosa to work beyond her December 2022 J-1 Visa expiration by completing an Application for Permanent Employment Certification (ETA-9089) on behalf of Ms. Barbosa for a live-in household nanny position (Exhibit A). She placed ads in *The Washington Post* (Exhibit B) as required, but the application was later denied by the Dept of Labor (Exhibit C). No work authorization was allowed while it was pending.

### **December 30, 2022**

Barbosa's final payment from the Swalwell campaign was on December 30, 2022 (Exhibit L).

### **January 2023 – February 2025**

After the expiration of Barbosa's J-1 Visa in December 2022, no payments to Barbosa appear in Swalwell campaign filings for the two years of 2023 and 2024 (Exhibits M, N). Nevertheless, Barbosa appears in numerous social media photos with the Swalwell family throughout 2023 and 2024, indicating continued close association and ongoing domestic childcare responsibilities despite the absence of known lawful work authorization (Exhibits G, H). Photos include:

- July 24, 2023: Barbosa at a White House picnic with the Swalwell children and family
- July 24, 2023: Barbosa at the national mall hugging a Swalwell child
- Sept 10, 2023: Barbosa with a Swalwell child attending a Washington Nationals game
- Mar 17, 2024: Barbosa is seen behind Swalwell at a St Patrick's Day Parade
- Apr 14, 2024: Barbosa is at National Harbor, Maryland near the convention center
- June 5, 2024: Barbosa is at a White House Picnic (from June 4)
- Oct 14, 2024: Barbosa pushing Swalwell boy in a cart for Halloween pumpkin pick
- Oct 31, 2024: Barbosa escorting younger Swalwell son for Halloween night
- Oct 31, 2024: Barbosa escorting older Swalwell son for Halloween night
- Nov 16, 2024: Holding Swalwell child in a family birthday photo

### Student at Community College

Public records indicate Barbosa's enrollment at Northern Virginia Community College beginning August 21, 2023 when Fall Classes begin. If Ms. Barbosa obtained F-1 student status, such status would which limit work to 20 hours per week, and only on campus. Living full-time with the employing family and performing childcare duties is incompatible with F-1 status and could be unauthorized employment. Barbosa is studying for a one-year, two-semester certificate in Early Childhood Development Career Studies. However, Barbosa completes the program in four semesters spanning two academic years, graduating in May 2025. The extended duration is consistent with full time work and part-time enrollment.

### 2023 Payroll Tax Reimbursement

Eric Swalwell charges his campaign \$9,713.42 for "Payroll Tax for Campaign Childcare Reimbursement," despite no official campaign payments to Barbosa in 2023. Total campaign childcare disbursements to two individuals amount to only \$3,006.25. Swalwell's payroll tax reimbursement raises questions whether it was for payments to Barbosa (Exhibit M).

### **February 28, 2025 – December 23, 2025**

On February 28, 2025, for the first time in over two years, Barbosa receives official weekly Swalwell campaign payments through September 26, 2025, totaling \$40,439.83 (Exhibit O). Additional childcare reimbursements to Swalwell for \$16,131.37 may indicate additional payments to Barbosa. Social media posts in 2025 (Exhibit I) are similar to prior years.

### **January 23, 2026**

Public social media posts by Barbosa in January 2026 continue to place her near the Swalwell home (Exhibit J).

## **8. Knowledge and Intent**

The March 2022 Permanent Employment Certification (ETA-9089) filing demonstrates awareness that J-1 authorization would expire. Subsequent payment patterns and continued apparent employment may warrant review as to whether proper authorization existed.

Publicly available information suggests employers Eric Michael Swalwell and Brittany Watts Swalwell continued residence and apparent employment following expiration of J-1 authorization.

Public records do not indicate that new employment authorization was obtained by Barbosa after her J-1 Visa had expired in 2022.

## **9. Potential Violations for Review**

The foregoing facts warrant agency review to determine whether:

- Employment occurred following expiration of J-1 authorization;
- Proper employment authorization existed during 2023–2024;
- Required I-9 compliance was maintained;
- Applicable tax withholding and reporting obligations were satisfied.

**Conspiracy**

18 U.S.C. § 371 – Conspiracy (if two spouses agreed to illegal employment or conceal it)

**Tax & Labor Law Related**

26 U.S.C. §§ 3101, 3111, 3402 - Failure to Withhold and Pay Employment Taxes

**10. Request for Investigation**

I respectfully request that Homeland Security Investigations review the foregoing facts and determine whether violations of federal immigration, labor, or tax laws occurred, and take appropriate enforcement action.

This complaint is based solely on publicly available records. DHS components have access to immigration filings and employment authorization records and may subpoena records not available to the public. This submission respectfully requests agency review of those records.
